

HSK-HSKK exam registration guide

1. Open the following website in Google Chrome or Firefox: <https://www.chinesetest.cn>
2. In the top-right corner of the screen, select the English language by clicking on the "EN" button:



3. In the top-right corner of the screen, click on the "Log In" menu.



4. Select the "Register Now" option.

CTI's Registration Agreement

The Chinese testing service website www.chinesetest.cn (hereinafter referred to as "Website") is an Internet site operated by CTI Co., Ltd. (hereinafter referred to as "CTI"), and provides the user with services including online information browsing, online registration for Chinese tests, etc.; the user should take the time to read this Agreement carefully before applying to register an account. For users under 16 years of age, please read this Agreement and other agreements mentioned above together with your legal guardian, paying special attention to the terms of use for minors.

I. Entry into Force and Confirmation of this Agreement

This Agreement applies to all services provided on the Website. By accepting any service provided on the Website, the user agrees to be bound by this Agreement.

By starting the registration procedure and clicking on the "I Accept" button, the user has come to an agreement with CTI and is voluntarily bound by this Agreement.

By using the services on this Website, the user agrees to the terms of the services used and announcements made by CTI concerning such services.

6. On the next screen, enter your username and provide an email address that you actively use. Set a password of at least six characters (containing uppercase and lowercase letters and a number). Repeat the password, then click on the "Register" button after completing the required fields.

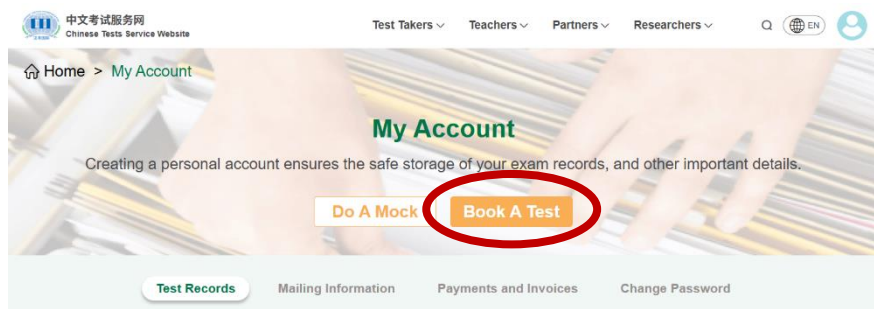

7. After registration, you will see your profile, where you can select the "Book A Test" option to register for an exam.



8. Choose whether you want to take the HSK (written) or HSKK (oral) exam. Specify the exam level and select the "Paper-based Test" option. Then choose the exam date, Europe as the continent, Hungary as the country, and the Confucius Institute as the exam venue. Click the "Next" button to proceed.

9. For some written exam levels, the corresponding oral exam is mandatory. A notification window will appear about this requirement. Click the "Submit" button to proceed.

Tips

Note: Candidates for HSK Levels 3-6 must also register for an HSK speaking test (The scores will be shown on the same score report). The rules are as follows——

1. HSK Level 3 —— HSK Speaking (Primary);
2. HSK Level 4 —— HSK Speaking (Intermediate);
3. HSK Levels 5/6 —— HSK Speaking (Advanced).

*If you still need to take HSK, please select the HSK level first.

10. On the next screen, enter your name (in the same order as it appears on the identification document you will use), date of birth, gender, nationality, the type and number of your identification document, phone number, address, mother tongue, and the number of years you have been studying Chinese. Then specify your status (e.g., as a student, a graduate, or other).

11. Next, click on the "Select Photo" button to upload an ID photo that meets the following criteria: The photo must have a white background and be in JPG format. The applicant must not be wearing a hat in the photo. The file size cannot exceed 100 KB (180x240 pixels). After uploading the photo, click "Next." If you need to return to the previous screen, click "Back."

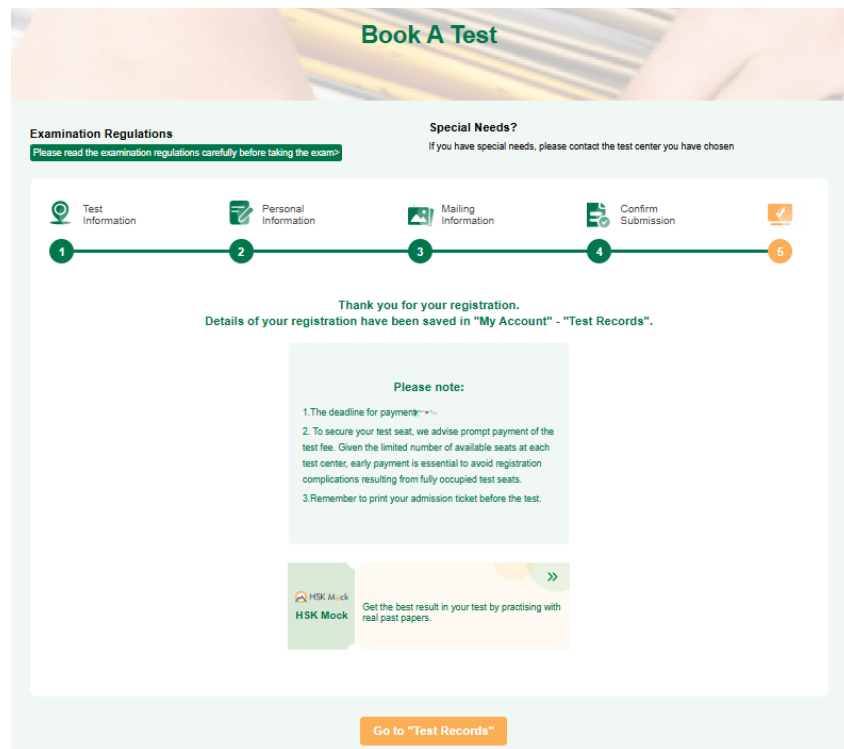
12. The next window will inform you that you can pick up your exam certificate at the designated Confucius Institute. Click "Next" to proceed.
